2017 Scheduled VLR Educational Sessions

“Fair Stateroom Assignments” – Fair Housing Act

It is imperative that Association Managers understand Fair Housing laws and the possible repercussions of a Fair Housing complaint on the association and community as a whole. This session will review the legal requirements and helpful guidelines for the Board and association to avoid FHA claims and remain in compliance with the Fair Housing laws. You can stay afloat with your licensing requirements by joining us for this session, which will be facilitated by CICB approved speakers and meets the Fair Housing class requirement for manager licensing/recertification training.

“You Can’t Handle The Cruise!” – Testifying in Court: Practical Tips on Serving As a Witness

This exciting and engaging session will explain how Managers and Board Members can make effective witnesses in court. This will be an interactive session with attorneys and a few community managers performing a role playing session, which will highlight and illustrate the best practices when testifying in court. If you find yourself in trouble on board, don’t face the Captain without knowing how best to represent your case.

“Tacking Maneuvers” – Amending Documents – The Old, The New and The Technical

In the aftermath of Tvardek v. Powhatan Village, what must an Association do to properly amend its documents? Words matter and technical requirements reign. The session will provide an overview of the amendment process for both condominium and property owners associations, and explain how to amend documents so that they are amended correctly the first time. The same old amendment maneuvers of yesterday may steer you in the wrong direction.

“Navigating Rough Seas” – Human Resources

This session will provide a general overview on various types of discrimination that are actionable under Title 7, as well as the criteria needed to be eligible for action under Title 7. There are many actionable items which can lead you into rough seas, such as sexual harassment, racial profiling, discrimination based on religion, gender, etc. Attend this session to obtain a general overview of the potential legal pitfalls in Human Resources and how to avoid getting caught up in dangerous waters.

“Avoiding Captain Hook” – Fraud – Detection/Prevention

In today’s world, fraud can occur far too easily. This course will review the three most common types of fraud and subsequently, how to detect and prevent it. Being aware of these three types of fraud and developing methods to identify when fraud is occurring and taking active measures to prevent it can keep you and your organization out of the clutches of Captain Hook.

“Batten Down the Hatches” – Important Insurance Updates – What Community Association Professionals Need to Know Now

Despite the 2015 change to the VA Work Comp Act, the question of whether an Association without employees is legally obligated to purchase Work Comp coverage in Virginia remains unsettled, as Associations now find themselves facing legal sanctions and financial penalties for cancelling existing coverage. This session will update the current interpretation being communicated by the VA Work Comp Commission, as well as the options available to Associations. In addition, we’ll examine and explain the relatively new arena of Cyber Liability exposures to loss, and the new coverage options and risk management approaches available to both management professionals as well as Associations to deal with this very real threat. Finally, this session will take a look at the increasing number of workplace violence incidents touching community associations and the management industry alike, and examine the insurance considerations which must be understood. Join us for this session so you can be prepared when that Category 5 insurance claim hits!

“Making Headway” – Evolution of Communications – From Tin Cans to Smart Phones – Changing the Game

Technology has given us amazing tools to communicate and maintain relationships, yet the quality of communications and human interaction is eroding. How can we keep the technology tail from wagging the dog, deal with insane expectations, connect with others AND save time? It’s time to change the game.
